5. Announcements

Board President, Cynthia Schulz turned the meeting over to Superintendent and CEO, Amber Gibbs who gave the following announcements:

- Cuyahoga DD's annual Employee Years of Service Recognition Brunch was held today. Staff with consecutive years of service in increments of 5 years all the way up to 35 years were recognized. These staff represent a total of 1,290 hours of combined service to the agency. Thanks to Board member Steven Licciardi and Board vice-president Steve Scheidt for attending.
- The Community Development Department held a successful Family Fun Fair on May 6 with over 200 people attending. There are three more planned this summer – Board members were provided with postcards at the last meeting that list the dates. The Family Fun Fairs are for families with children age 14 and under.
- In line with our plans to reach people of all races and ethnicities all over Cuyahoga County, this weekend we had an information table at the Asian Festival both Saturday and Sunday with over 150 people stopping by.
- The All-Staff meeting which was held in early May was very successful. This event was a chance for us to get together and connect AND professional development opportunities were offered where many staff earned continuing education credits they need for their positions.
- Three representatives from our agency attended the Alcohol, Drug Addiction, and Mental Health Services (ADAMHS) Board annual meeting. They talked about a new crisis facility – so we are eager and excited to talk to them about that option.
- Amber met with the CEO of the Cuyahoga Board of Health, Roderick Harris. He has been in this position for just over a year. Our staff worked with his predecessor Terry Allen very well, especially during the COVID pandemic and the rollout of vaccinations in early 2021. The Board of Health is beginning their strategic plan process and Amber volunteered to find Mr. Harris some people to interview if they are interested. They talked about the need for both psychiatry and dental services for people on Medicaid.
- The spring Ohio Association of County Boards (OACB) conference was held in early May. Cuyahoga DD staff presented at three sessions. The Discussion Topic tonight is a very abbreviated version of one of these sessions. All presenters did an excellent job and represented Cuyahoga DD well!
- The State budget is still with the Senate. The Ohio House increased allocation so DSP wages would be an average of \$18/hour. County boards are willing to put in money for an extra dollar an hour. However, the latest news regarding the Public Health Emergency is that the Ohi Department of Medicaid (ODM) is considering extending some of the flexibility that was allowed during COVID, specifically parents being permitted to be paid caregivers of their minor children. If this is permitted, it could create some very significant financial issues for county boards. More information to come as we hear how things develop.

6. Discussion Topic - *Intensive Supports to Youth and Young Adults*

The presentation was provided by Cuyahoga DD staff: Cassandra Brown - Supervisor, Support Administration - Multi-System Services; Dr. Rick Cirillo - Chief Clinical Officer; Lori Mago - Division Manager, Children's Services & Assistive Technology; Kelly Rainey - Special Instruction Manager.

An extended version of this presentation was given at the spring Ohio Association of County Boards (OACB) conference. The presentation slides are attached to these minutes as a permanent part of the record of this meeting.

A. ADAMHS Board - Shared Placement Costs

Intensive Supports for Youth/Young Adults



In-Home

Intense Support Team

- Supports young people with unique and/or intense service needs.
- Capacity varies.
- Support provided by Cuyahoga DD and/or external providers.



Away from Home

After-School

- Supports young people in recreation and leisure activities.
- East and West locations.
- Transportation may be available.

1/2-Day Weekend Recreation

- One (1) Saturday each month.
- East and West locations.



Out of Home

Traditional Respite

- Warrington (planned or emergency respite).

Extended Respite

- Fowles, a youth residential facility, offers additional treatment and programming.



What led to the development of the Intensive Support Teams (IST) and the ICF/Respite homes?

- Gap in services for individuals with complex needs
- Stakeholder feedback
- Differentiated interventions to keep families together
- Utilizing internal resources differently
- Community Partnerships



Intensive Support Teams (IST)...

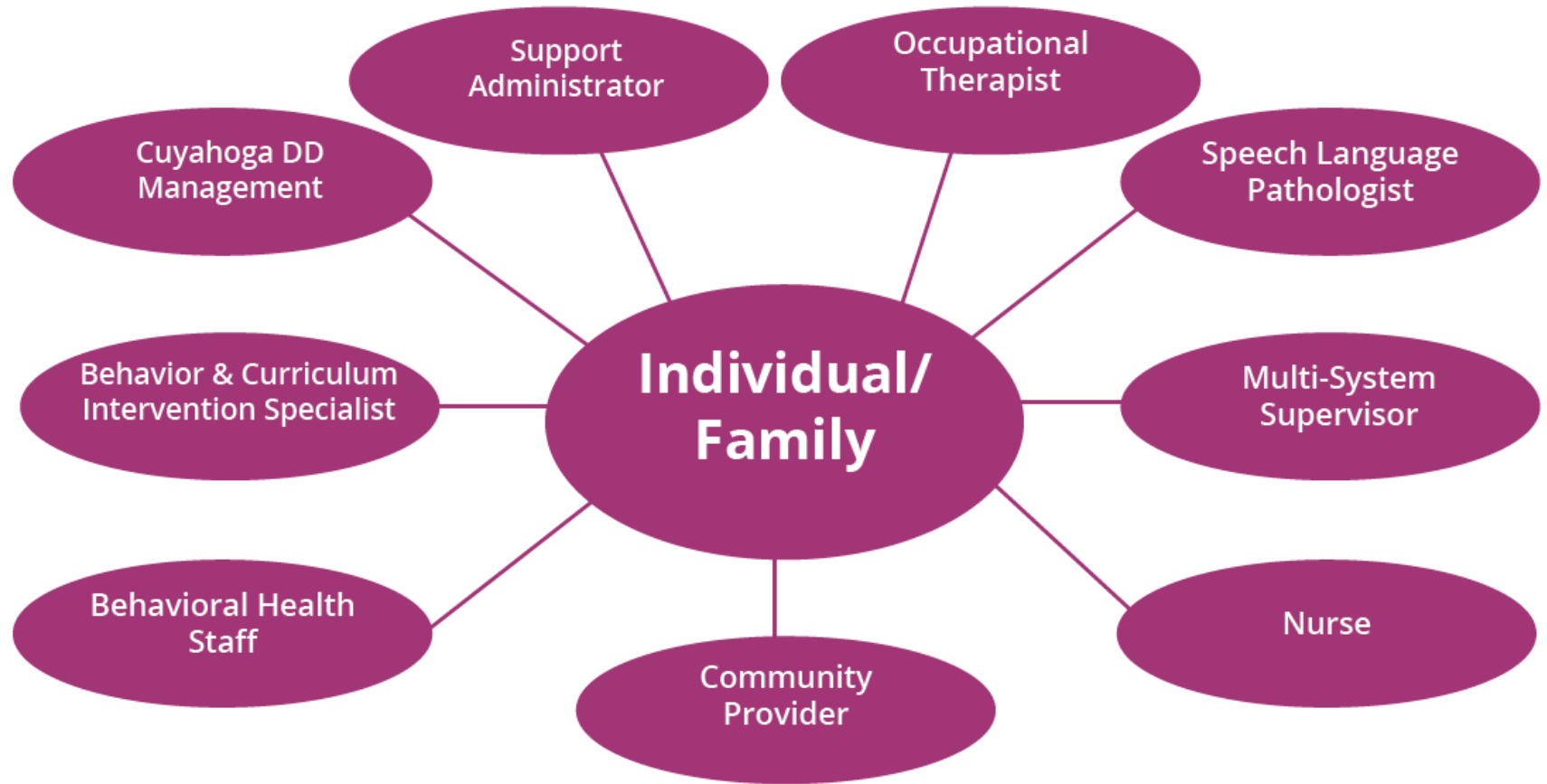
- Serve individuals aged 10-25 in crisis whose behaviors cause significant worry, and/or risk of harm to self and others.

IST services are:

- Intensive
- Short term
- Personalized to meet priority areas
- Provided in the home and/or community
- No cost to families
- Identified Internally



Who makes up IST?

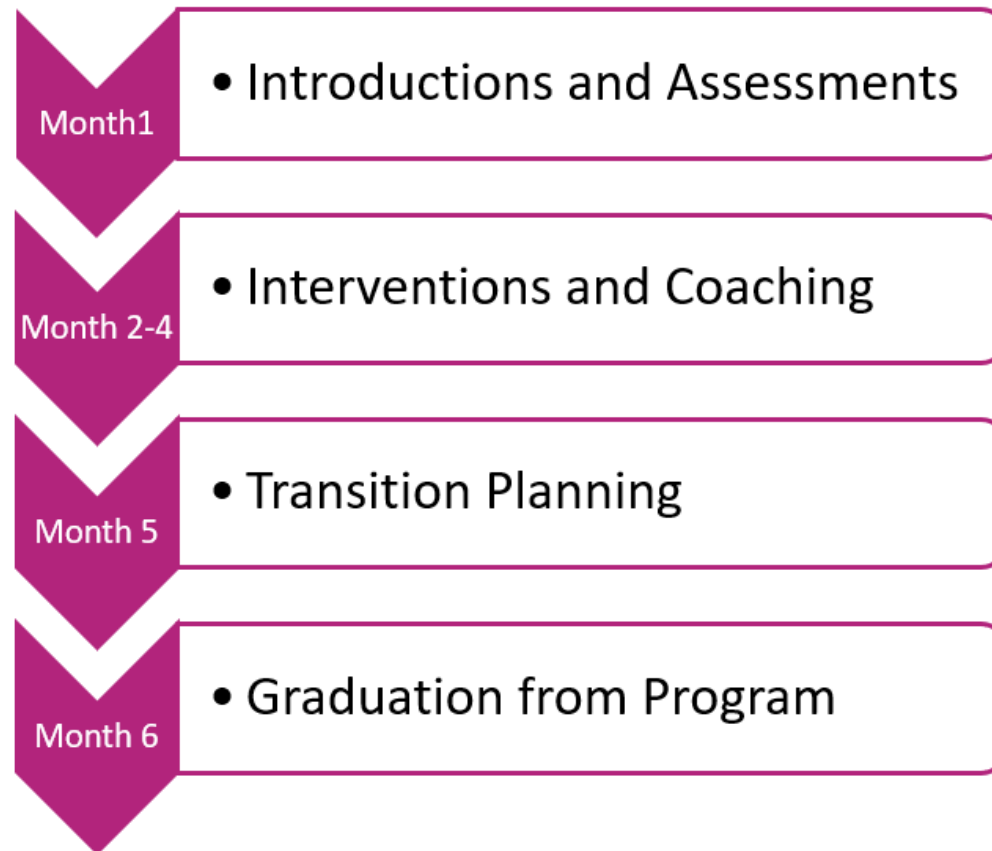


*The following disciplines will serve as needed: Assistive Technology Specialist, Physical Therapist, and other therapies as appropriate.

What has the IST accomplished?

As of May 2023...

- 31 families have been or are currently being served by IST
- 50% of the individuals served by the IST for more than 3 months have demonstrated between a 5-54% decrease in their overall CANS score
- 9 families are on the waitlist
- Established After-school and Weekend Programs
- Growing community interest



Media and Family Success Stories

Beachwood Buzz

Vidya Seshadri and Prakash Hariharabalan have two children: **Kripesh Narayanan**, a 17-year-old-son who attends the KidsLink School; and **Pooja Narayanan**, a rising 5th grade daughter at Hilltop. Vidya is currently a home maker, while Prakash is the director of Data Analytics and Strategy at Signet Jewelers. We asked Vidya to share her thoughts:

Kripesh was diagnosed with autism when he was 4 ½ years old, in Evanston, Illinois. We felt extremely sad when we received the diagnosis. We were worried what the future would hold for him and for us as a family. Our worst future fear had come true.

The biggest misconception is that kids with autism like to be aloof and don't want to be touched by anyone. Our son loves being with people and loves to hug everyone. Although he is already 17 years old, Kripesh is a little kid at heart. He is a very good hugger and likes to be around people.

Our biggest achievements have been getting him potty trained, writing the alphabet, and teaching him to swim.

We have learned that we must adapt our everyday routine and lifestyle. We require a lot of planning before every activity. We must accept that plans could change at any moment.

The biggest misconception is that kids with autism like to be aloof and don't want to be touched by anyone. Our son loves being with people and loves to hug everyone.

Beachwood has been very supportive and has done what was necessary to address and meet our son's needs, including placing him outside the school district and providing specialized transport.

The main reasons we participate are to increase our parenting knowledge and skills and to provide support to each other by sharing our day-to-day issues of raising kids with disabilities. I would like to see us start an adaptive sports program in Beachwood for our kids, and to talk more about

resources available for the post-school life stage.

The pandemic has completely changed my life. I had to quit my behavior therapist job and be my son's full-time therapist. My son's anxiety level has heightened badly, and he could not understand the reasons for lockdown and school closure. His routine was changed completely and it took three months for him to understand online therapies.

The community has been very supportive of us by including us in get-togethers, listening

to our day-to-day challenges, and offering help during emergencies. We would like to thank Satish Vishwanath and Ramya Ramadurai for extending support to our family always.

We would also like to acknowledge the Cuyahoga County Board of Developmental Disabilities. They have been very supportive by providing funding for various equipment, consulting, and counseling services for parents, helping with strategies to handle certain behaviors, and creating social stories, etc.
